Debra McMillan, 4511 Hoeneke, stated previously the Council discussed that the tax rate would stay the same; however, property values have increased and the residents of the community who are on fixed incomes will pay more taxes. There were discussions on two bond issues and this will also further burden the residents of the community. Her question for Council was when the residents can expect improved departmental efficiency to counter act the ever increasing tax burden.

Health, Life, and AD&D, Vol. Life, Dental And Vision Insurance For The Plan Year

Beginning October 1, 2015

Jenni Haff, Wortham Insurance, presented the options for health insurance. There was a 48.5% increase this year and after reviewing the options, she recommended the City consider Humana Option one. The was a 5% increase in dental with Humana, the vision rate did not change, and the life insurance rate did not change.

City Manager Vernon informed Council staff's recommendation is Humana Option One.

Mayor Pro-Tem Faulkner moved to accept Humana Option One, seconded by Council Member Grant. The motion carried with a 7-0 vote.

b. <u>Discussion And Possible Action To Consider Resolution No. R-2015-660 Extending The Contract With Linebarger, Goggan, Blair & Sampson LLP, Attorneys At Law For The Collection Of Delinquent Taxes</u>

Carri Wells, Linebarger, Goggan, Blair & Sampson, LLP, presented the report for the collection of delinquent taxes and explained the procedures to collect taxes when they are delinquent.

City Manager Vernon stated staff recommendation was to extend the contract for another five years.

Council Member Grant moved to accept Resolution No. R-2015-660 extending the contract with Linebarger, Goggan, Blair & Sampson LLP, Attorneys at Law for the collection of delinquent taxes, seconded by Council Member Lehman.

c. <u>Discussion And Possible Action To Consider Ordinance No. O-2015-770 Amending Section 97.12(B) Of Chapter 97 Of The Code Of Ordinances Of The City Of Kirby, Texas, In Regard To The Number Of False Burglary Alarms That Can Result In Suspension Of Or Refusal To Renew An Alarm System Permit, This Is The First Reading.</u>

City Manager Vernon stated this is a legislative change and asked Council to consider amending Section B to allow a change to the number of false alarms. This ordinance will go into effect September 1, 2015.

Council Member Grant moved to adopt Ordinance No. O-2015-770 amending Section 97.12(B) of Chapter 97 of the Code of Ordinances of the City of Kirby, Texas, in regard to the number of false burglar alarms that can result in suspension of or refusal to renew an alarm system permit, seconded by Council Member Romens.

The motion carried with a 7 - 0 vote.

e. <u>Discussion And Possible Action To Consider Ordinance No. O-2015-771 Amending Section 91.045(E) Of Chapter 91 Of The Code Of Ordinances Of The City Of Kirby, Texas, To Revise The Period Within Which A Decision Of The Municipal Court As To Destruction Or Removal Of An Animal May Be Appealed, To Revise The Period During Which A Destruction Or Removal Order May Be Executed, And To Provide For Release Of An Impounded Animal To The Owner Or For The Owner To Remain Liable For Costs To House And Care For An Impounded Animal. This Is The First Reading.</u>

City Manager Vernon informed Council this is another legislative change.

Council Member Grant moved to adopt Ordinance No. O-2015-771 amending Section 91.045(E) of Chapter 91 of the Code of Ordinances of the City of Kirby, Texas, to revise the period within which a decision of the municipal court as to destruction or removal of an animal may be appealed, to revise the period during which a destruction or removal order may be executed, and to provide for release of an impounded animal to the owner or for the owner to remain liable for costs to house and care for an impounded animal.

The motion carried with a 7 - 0 vote.

g. <u>Discussion And Possible Action To Authorize The City Manager To Sign An Interlocal Cooperation Agreement Establishing Concurrent Jurisdiction Between The City Of Kirby And The City Of San Antonio.</u>

Chief Bois informed Council he was requesting authorization for an Interlocal cooperation agreement establishing concurrent jurisdiction between the City of Kirby and the City of San Antonio. SB 631 was passed by the Senate allowing a change to Section 791 of the Texas Government Code. This Section provides that governmental entities of the State may contract with each other to provide governmental functions and services and provide fire protection and associated services to protect public health.

City Manager Vernon informed Council the effective is October 1, 2015. Marc Schnall reviewed the agreement and the changes that were made have been accepted by San Antonio. San Antonio will use the agreement presented by Marc Schnall as a model for area cities.

Council Member Grant moved to authorize the City Manager to sign an Interlocal Cooperation Agreement establishing concurrent jurisdiction between the City of Kirby and the City of San Antonio, seconded by Council Member Spradling.

The motion carried with a 7 - 0 vote.

h. <u>Discussion And Possible Action To Consider Ordinance No. O-2015-772</u>

<u>Amending the 2014-2015 Municipal Budget Of The City Of Kirby. This Is the First Reading.</u>

City Manager Vernon the memo summarizes the requested amendments. The net effect of the overall budget amendment to the general fund is \$134,973 and that's a reduction in expenses. Revenue decreased by \$477,214 and expenditures decreased by \$612,187.

Council Member Spradling moved to adopt Ordinance No. O-2015-772 amending the 2014-2015 Municipal Budget of the City Of Kirby, seconded by Mayor Pro-Tem Faulkner.
