1. <u>Call Meeting to Order</u>

Mayor Pierce called the meeting to order at 7:00 P.M.

Council Member Lehman moved to approve the minutes of February 13, 2020; seconded by Council Member Apodaca. The motion carried with a 4-0-1 vote.

b. <u>Employee Retirement Recognition</u>

City Manager Vernon recognized Carlos "Charlie" Alfaro, Fire Chief. He started working for the City 30 years ago. He has rendered many years of dedicated service to the City of Kirby. He became Fire Chief in January 2017 and he has served three years as Chief. Tonight, we want to give him a token of our appreciation to say thank you. Tomorrow is officially his last day and he will be going to enjoy retirement. Chief Alfaro Charlie extended his appreciation for everyone who was present. He asked that city staff, city council and everyone else take care of his "kids." He said his personnel are his kids.

Mayor Pierce closed the regular meeting and opened the public hearing at 7:09 P.M.

Juan Juarez, property owner, was present to answer questions. Ms. Tania Vazquez translated for him. His property is on a corner lot and he wanted to construct a carport on the side of his property facing Buzz Aldrin. He asked if he could construct his carport five feet into the side yard setback.

There were not any proponents or opponents.

b. On A Request For A Specific Use Permit To Allow The Property Located At NCB 5941A BLK 1 Lot W IRRG 150.59 FT Of 17, Otherwise Known As 121 Edalyn, Kirby, TX 78219, Which Is Zoned Commercial, Office And Retail (C-2) District To Be Used As A Single Family Dwelling.

Ramesh K. Mahbubani, property owner, presented his request and provided the history on the ownership of the property. He wants to continue using the property as a residential property.

Mayor Pierce closed the public hearing and opened the regular meeting at 7:13 P.M.

9. Discussion And Possible Actions

Council discussed this request. Council Member Salazar moved to deny the Variance to the Zoning Ordinance – Single Family Dwelling District (R-1), Section 153.016 (B) (6) (b) to permit an encroachment into the fifteen (15') foot side yard setback for the construction of a carport located at CB 4018B, BLK 10 Lot 1, otherwise known as 4802 Binz Engleman Rd., Kirby, TX 78219; seconded by Council Member Lehman. The motion carried with a 4-1 vote.

b. <u>Discussion And Possible Action On A Request For A Specific Use Permit For The Property Located At NCB 5941A BLK 1 Lot W IRRG 150.59 FT Of 17, Otherwise</u>

Known As 121 Edalyn, Kirby, TX 78219, Which Is Zoned Commercial, Office And Retail (C-2) District To Be Used As A Single Family Dwelling.

City Council discussed this request. Mr. Mahbubani said he will continue the clean-up of the property.

There was no action taken on this item and it will be brought back on a future agenda.

c. <u>Discussion And Possible Action On City Of Kirby FY 2018-2019 Audit Report</u>

Deborah Fraser, Armstrong, Vaughn, presented the 2018-2019 Audit.

Council Member Apodaca moved to accept the City of Kirby FY 2018-2019 Audit; seconded by Council Member Salazar.

d. <u>Update, Discussion And Possible Action On Potential Future Boundary Expansion</u>

Joseph Johnson, Sunrise Neighborhood Association, explained he did not arrive in time to sign up to speak and asked if City Council would allow him to speak.

Mayor Pierce asked Council if they would consider allowing Mr. Johnson time to speak on this item because he did not arrive in time to sign up to speak.

Council Member Salazar move to allow Mr. Johnson the opportunity to speak; seconded by Council Member Apodaca. The motion carried with a 5-0 vote.

Mr. Johnson explained his concern with the boundary expansion. He spoke in regards to information he received that Kirby is considering annexing Sunrise.

The City Council discussed the boundary expansion and the fees associated with the expansion.

City Manager Vernon provided the engineering fees: \$6,800 plus \$180 per hour for all three areas and the quote is good for 30 days.

Mayor Pro-Tem Aldrich moved to accept the proposal for M&S Engineering's to provide the scope of work quote described for the lump sum of \$6,800 plus the field work performed by Sherwood Surveying coordination of the work by M&S Engineering to be billed based on the hours at the rate of \$180 per hour (max eight hours) not to exceed \$1,440; seconded by Council Member Salazar. The motion carried with a 5-0 vote.
