This Is The Second Reading.</u> Council Member Pierce moved to accept Ordinance No. O-2020-874 an ordinance amending the Zoning Ordinance of the City of Kirby, Texas, to grant Specific Use Permit #2019-014 for use of the property at 5863 Binz Engleman Road, Kirby, Texas for the purpose of development of an apartment complex with approximately seventy apartment units, seconded by Council Member Grant.  Discussion And Possible Action To Consider The Proclamation Issued On March 18, 2020, By Governor Abbott Authorizing All Political Subdivisions Holding A General Or Special Election On May 2, 2020 To Postpone Their Election To The November 3, 2020 Uniform Date Due To The Health And Safety Of Voters, Election Workers, And Local Election Officials, And Consideration Of An Ordinance Regarding Same

City Manager Vernon provided a recap of the current election information for the May 2, 2020 General and Special Election. On March 18, 2020 Governor Abbott issued a proclamation that would allow political subdivisions that hold their elections on May 2, 2020, to move their General and Special Elections for 2020 only to the next uniform election date, occurring on November 3, 2020.

Mayor Pierce recognized the citizens signed up to speak:

Steve Pitmon – He spoke in regards to the date of the election.

Michael Martin – He asked Council to consider waiting on Bexar County Elections Administrator to announce their decision on this election.

B.J. Voigt – She was not able to join the meeting; she provided her questions in her email. She inquired about the Kirby stickers, curfew for Kirby, and suggested postpone action on this item tonight to see what Bexar County does.

After discussing this item, Council Member Grant moved to postpone the May 2, 2020 General Election and Special Election to November 3, 2020; seconded by Mayor Pro-Tem Aldrich. The motion carried with a 6-0 vote.
