- 2.) Roger Romens He said at the last Council meeting the General and Water Fund budgets were amended and dispensed with second reading. This action was troubling because it did not afford the general public to opportunity for input or questions. Previously the City Attorney advised Council about dispensing of second readings and said it was for extreme emergencies only. The motion passed unanimously and then dispensed with second reading. He has a concern was about replacing the fence at the water tower for \$10,000.

a. <u>Crime Control Prevention District Fiscal Year 2020-2021 Budget</u>

1.) Chris Garza – He spoke about the approval of the Crime Control Prevention District budget. We are approving a budget for a wish list. He suggested removing the line item in case it's for an item we may never receive.

# 9. <u>Discussion And Possible Actions</u>

a. <u>Discussion And Possible Action To Consider Transferring Ownership Of Explorer</u>
Street And Telstar Drive To Springfield Manor Apartments Management Company

City Manager Vernon provided history on this property. There were two options: City of Kirby could completely rehab Explorer Street and Telstar Drive or if funding isn't available for funding the two streets, then transfer full ownership of the two streets at zero cost, due to the amount of work needed on the streets, to Springfield Manor Apartment Management Company. During discussion with the city attorney, we were reminded that we are not able to give away City owned property. It would have to be sold at fair market value. Staff's recommendation is looking at an option letting them take over the streets because we are limited in our ability to maintain them. We will keep in mind that we still own the utilities and if needed, would have to go in and take care of any issues.

Paul Fletcher, on behalf of city attorney, was available to answer questions.

Mayor Pierce provided the street assessment on the two streets. The street assessment is located on our website. Explorer was rated 49 or 3.04 and Telstar was rated 75 or 2.69.

Michael Shackleford said he represents the owner, and not management company. He provided history on the property. They had a full assessment done on the property and it does not match the City's assessment. They are willing to take responsibility for ownership at no cost considering the cost to rehab the streets. They received the information from Ms. Vernon that there cannot be a transfer at no cost. He said other municipalities have done a long-term lease for 70 years for \$1.00 and they would take ownership of the road with the long-term lease. They

would maintain, rehab and anything else that the streets needed. The municipality would have access to the right of way for utility improvements if needed. (33.27)

Mr. Fletcher said since we just now heard about the long-term lease, he would like to look at this option.

Council concurred to bring back first meeting in August.

b. <u>Discussion And Possible Action On Ordinance No. O-2020-880 An Ordinance Adding Section 36.09 To Chapter 36 Of The Code Of Ordinances Of The City Of Kirby, Texas, Establishing A Failure To Appear Offense, Setting Out A Defense To Said Offense, And Authorizing The Judge Of The Municipal Court To Assess A Failure To Appear Fee And Adding Section 36.10 To Chapter 36 Of The Code Of Ordinances Of The City Of Kirby, Texas, Providing That A Failure To Appear Fee Shall Not Exceed \$500.00. This Is The Second Reading.</u>

Council Member Grant moved to approve Ordinance No. O-2020-880 an Ordinance adding Section 36.09 to Chapter 36 of the Code of Ordinances of the City of Kirby, Texas, establishing a Failure to Appear offense, setting out a defense to said offense, and authorizing the Judge of the Municipal Court to assess a Failure to Appear fee and adding Section 36.10 to Chapter 36 of the Code of Ordinances of the City of Kirby, Texas, providing that a Failure to Appear fee shall not exceed \$500.00; seconded by Council Member Salazar. The motion carried with a 6-0 vote.
