

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of .698942 per \$100 valuation has been proposed by the governing body of the City of KIRBY.

PROPOSED TAX RATE	\$0.698942 per \$100
NO-NEW REVENUE TAX RATE	\$0.679170 per \$100
VOTER-APPROVAL TAX RATE	\$0.698942 per \$100
DE MINIMIS RATE	\$0.805072 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for the City of KIRBY from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that the City of KIRBY may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for the City of KIRBY exceeds the voter-approval tax rate for the City of KIRBY.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for the City of KIRBY the rate that will raise \$500,000, and the current debt rate for the City of KIRBY.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that for the City of KIRBY is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on August 27, 2020 at 7:00 PM at Kirby City Hall 112 Bauman St., Kirby, TX 78219.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, the City of KIRBY is not required to hold an election at which voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of the City of KIRBY at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by the City of Kirby last year to the taxes proposed to be imposed on the average residence homestead by the City of Kirby this year:

Total tax levy on all properties	\$2,693,750	\$2,780,084	<i>increase of</i> \$86,334 OR 3.20%
