# 1. <u>Call Meeting to Order</u>

# 6. <u>Consideration Of And Action On Minutes</u>

a. <u>Public Hearing/Regular Meeting – August 27, 2020</u>

Council Member Apodaca moved to approve the Public Hearing/Regular Meeting minutes of August 27, 2020; seconded by Mayor Pro-Tem Aldrich. The motion carried with a 6-0 vote.

# 7. <u>Presentation</u>

a. September 11<sup>th</sup> Special Presentation – Fire Chief Glenn Levy

Chief Glenn B. Levy recognized the "Flag of Hero's" that contains the names of all of the firefighters that gave their lives on September 11 and those who have died since that day. He presented the "Flag of Hero's" to the firefighters to recognize them for what they do every day. Mayor Pierce thanked the first responders.

a. <u>Discussion And Possible Action On Appointing Up To Four Alternate Members To</u>
The Building And Standards Commission

b. <u>Discussion And Possible Action On Entering Into An Agreement With Slow-Pitch</u>
<a href="Amateur Softball League">Amateur Softball League</a>, For Use Of Land Owned By The City Of Kirby To Conduct Slow Pitch Amateur Softball League Athletic Functions

Mayor Pro-Tem Aldrich moved to table this item until representative is available to attend the meeting; seconded by Council Member Salazar. The motion carried with a 6-0 vote.

- c. <u>Discussion And Possible Action On Volleyball Court Installation</u>
- 1. Roger Romens He spoke in favor of the volleyball court and suggested Hugo Lentz and Friendship Parks as locations.
- 2. Susan Street She spoke about the location of the volleyball court and other concerns. She supported Friendship Park as a location.
- 3. B.J. Voigt She spoke in favor of the volleyball court and suggested a location large enough for multiple volleyball courts and voiced other concerns.
- 4. Mr. Snow He spoke about the volleyball courts as a way to keep the youth off the streets and safe. If they stay busy, they may stay out of trouble.

Council Member Grant recognized the comments from the citizens. He wants the youth to have a centrally located volleyball court so they won't have a long distance to travel to use a court. His suggestion is to place the court on the same side as the basketball court by the Senior Center. He has everything that is needed, except the net.

Council Member Grant moved that he be allowed to place the volleyball court somewhere in the John Sterling Park area.

Council discussed the location of the volleyball court. Council Member Grant withdrew his motion.

Council Member Apodaca moved to postpone this item to look at locations and materials; seconded by Mayor Pro-Tem Aldrich. The motion carried with a 5-0-1 vote.

d. Discussion And Possible Action On Live Streaming City Council Meeting

Stephen Pitmon said he got together with a small group of people to research live streaming. They had a conference with WebEx and they had decent features which he shared with the city council. The expenses associated with the software would be determined by the equipment that would be required. Also, Granicus is live, but he's not sure of the expense.

City Manager Vernon said she met with Mr. Pitmon to talk about this item. She said Council discussed this in 2015, 2017 and 2019. Due to the expense the City Council chose the audio which is the most cost effective. If installed equipment here, the cost estimate is \$26,089 for the recording equipment. To air the video the options were YouTube and Cloud.

City Council discussed the options and expense.

Mr. Arambula said he is familiar with Granicus which is a great system, but it is pricey. One thing it does not have is two-way communication capability.

e. <u>Discussion And Possible Action On Ordinance No. O-2020-883 Making Appropriations For The Support Of The City Of Kirby For The Fiscal Year Beginning October 1, 2020 And Ending September 30, 2021 Appropriating Money To A Sinking Fund To Pay Interest And Principal Due On The City's Indebtedness; And Adopting The Annual Enterprise And General Fund Budgets Of The City Of Kirby For 2020-2021 Fiscal Year. This Is The First Reading.</u>

Council Member Pierce moved to approve Ordinance No.O-2020-833 making appropriations for the support of the City of Kirby for the Fiscal Year beginning October 1, 2020 and ending September 30, 2021 appropriating money to a Sinking Fund to pay interest and principal due on the City's indebtedness; and adopting the annual Enterprise and General Fund Budgets of the City of Kirby for 2020-2021 Fiscal Year; seconded by Council Member Apodaca. The motion carried with a 6-0 vote.

f. <u>Discussion And Possible Action On Ordinance No. O-2020-884 Levying Ad Valorem Taxes For Use And Operation Of The Municipal Government Of The City Of Kirby, Texas For The 2020 Tax Fiscal Year; Providing For Apportioning Each Levy For Specific Purposes; And, Providing When Taxes Shall Become Due And When Same Shall Become Delinquent If Not Paid. This Is The First Reading.</u>

Mayor Pro-Tem Aldrich moved that the property tax rate be increased by the adoption of a tax rate of .698942, which is effectively 5.06 percent increase in the tax rate; seconded by Council Member Apodaca. The motion carried with a 6-0 vote
