Council Member Apodaca moved to approve Ordinance No. O-2020-887 ordering a Special Election on May 1, 2021, on amendments to the City Charter of the City Of Kirby, Texas; making provision for the conduct of the election including city intention to enter into a joint election agreement and/or a contract for election services with the Bexar County Election Administrator; resolving other matters incident and related to such election; and providing an effective date; seconded by Council Member Lehman. The motion carried with a 6-0 vote.

Mr. Michael F. Marcon, Principal and Ms. Lauren M. Grawey, Environmental Scientist were present to provide information on the Municipal Setting Designation for the former KLN steel facility located at 4200 N Pan Am Expressway.

Council Member Salazar moved to table this item to the next meeting to provide time to study this more and gather information; seconded by Council Member Pierce. The motion carried with a 5-1 vote.

g. <u>Discussion And Possible Action On Kirby Senior Center Gazebo Safety and Renovations</u>

Norma Hamby provided an overview on the Kirby Senior Center Board meeting when they discussed the gazebo. They received three quotes and approved one of the quotes in the amount of \$2,800.00. She identified some of the necessary improvements needed. She said this will be addressed on the Board's next agenda and if anyone has any questions, they can attend the meeting.

Mr. Michael Martin explained he was informed by a contractor what would be needed to improve the gazebo.

Mayor Pierce confirmed that a permit was issued for construction of the gazebo in 2011 and passed the inspections.

Mr. Harold Shaw asked if he could speak, because did not sign up to speak.

Council Member Apodaca moved to allow Mr. Shaw an opportunity to speak; seconded by Council Member Salazar. The motion carried with a 6-0 vote.

The last sector is October 26 and items must be placed at the curb before 7:00 A.M. She reiterated the Senior Center event on October 31.
