Council Member Grant moved to appoint Dr. John Bragen as EMS Medical Director; seconded by Council Member Apodaca. The motion carried with a 6-0 vote.

g. <u>Discussion And Possible Action To Approve An Agreement With San Antonio Pool</u>

<u>Management For Pool Management Services From December 1, 2020 Through November 20, 2022</u>

City Manager Vernon informed Council that the City's current agreement with San Antonio Pool Management expires on November 30, 2020. Staff recommends entering into a new 2-year agreement. The cost for year one is \$47,350 and the cost for year two is \$47,769. We allocated \$50,000 in our Fiscal Year 2020-2021 Budget.

Council Member Salazar moved to approve an agreement with San Antonio Pool Management for pool management services from December 1, 2020 through November 30, 2022; seconded by Council Member Martin. The motion carried with a 6-0 vote.

- j. <u>Discussion And Possible Action On Adding Speed Bumps And Stop Signs On Buzz Aldrin</u>
- 1.) Susan Street She said another city has a great plan for speed bumps the Council should consider adopting. She voiced her views on speed bumps for Council to consider.
- 2.) Harold Shaw He congratulated the new, existing and the old. Welcome aboard. He presented information on speed bumps for Council to view. Safety for the community, children, and elderly walkers is important. Speed bumps will require very little maintenance.
- 3.) B.J. Voigt On April 2011 her mother passed away and that same year on May 2011 a driver speeding on her street hit and killed her cat. She spoke to several city officials about speed bumps. She was told no because of fire vehicles. There are a lot of streets that need speed bumps.

Chief Bois talked about traffic, speed bumps and stop signs on Buzz Aldrin.

There was discussion about the construction of speed bumps.

Chief Levy confirmed speed bumps and emergency vehicles are not compatible. They will slow response time.

- 1.) Susan Street She suggested this should be processed through the Planning & Zoning Commission.
- 2.) Harold Shaw He said he is surprised this is on an agenda. We have to support our future and take care of our community.
- 3.) B.J. Voigt She asked where will it be located, what kind of materials, and who will maintain. She suggested setting a group to maintain the court.

There was discussion about maintaining and funding the volleyball court, time frame of construction. The construction plans will be provided to the City Manager.

- I. <u>Discussion And Possible Action On Cashing In CD To Cover Fiscal Year 2020-2021</u>

- 1.) B .J. Voigt She asked if the City has ever had to do this before and other questions regarding the number of CD's, reserve, when did we know, and how do we build it back up.

City Manager Vernon addressed the questions that were asked this evening. She identified what a certificate of deposit, the number of CD's and their amounts; why staff is making this recommendation; and what expenses will be paid with the cashed in CD.

Council Member Grant moved to allow City Manager Vernon to cash in the \$250,000 CD; seconded by Council Member Salazar. The motion carried with a 4-2 vote.

City Manager Vernon provided M&S Engineering's fee proposal and task order to provide engineering services related to the design, bidding and construction of the Borchers Drive under the CDBG program in the amount of \$34,400.

Council Member Salazar moved to accept proposal from M&S Engineering for engineering services on Borchers Drive Rehabilitation Project; seconded by Council Member Martin.

The motion carried with a 6-0 vote.
