Mayor Pierce closed the regular meeting and opened the public hearing at 7:16 P.M.

There were not any proponents or opponents requesting to speak.

Mayor Pierce closed the public hearing and reconvened the regular meeting at 7:17 P.M.

9. General Discussion And Possible Action

a. <u>Discussion And Possible Action On A Variance To The Building Code, Section 150.16 To Waive The Requirement Of The Installation Of An Automatic Sprinkler System In An 8,947.56 Square Foot Commercial Building; Located At NCB 10596 N IRR 94.99 FT Of S IRR 2717.68 FT Of TR-1 ARB P-100A LAND ONLY; Otherwise Known As 4700 Binz Engleman Road, City Of Kirby, Bexar County, Texas, 78219.</u>

Mayor Pierce said the Planning and Zoning Commission met on December 8, 2020 and their recommendation was to approve the variance with a 3-0 vote. The fourth member of the Commission was present at their meeting, but was not able to participate or vote because he lives within 200 feet of the area.

Heathe May, applicant, provided the history on the property. His brother was a partner and named him as the administrator of his estate. The structure is 9,000 square feet and adding an automatic sprinkler system would have a huge impact on their budget. They are prepared to install an alternate system. They are looking forward to moving forward if the variance is approved.

Diego McClain, partner, presented the events and uses of the building. He identified the ingress/egress of the building. He said he resides in Kirby and looks forward to giving back to the community.

Fire Chief Levy offered information addressing fire safety and Kirby regulations.

Council discussed the information that they received. They discussed ingress/egress, possibility of fires and effects on neighbors.

Council Member Apodaca moved to accept the variance request to the Building Code, Section 150.16 to waive the requirement of the installation of an automatic sprinkler system in an 8,947.56 square foot commercial building; located at NCB 10596 N IRR 94.99 FT of S IRR 2717.68 FT Of TR-1 ARB P-100A LAND ONLY; otherwise known as 4700 Binz Engleman Road, City of Kirby, Bexar County, Texas, 78219. The motion died for the lack of a second.
