g. <u>Update, Discussion And Possible Action On Republic Services Garbage Collection</u>
<u>And Recycle Program.</u>

Tom Armstrong, Republic Services, spoke about the garbage collection and recycle program. Glass is recyclable, but it is cost prohibitive. He provided Council a copy of the Spring 2021 mailer about recycling.

Council discussed the time frame to place carts at the curb and take back in to their property. Currently residents can place their carts at the curb starting at 8 PM. and retrieve them at 10 PM retrieval. Council discussed changing the time to place the cart at the curb to 5 PM and retrieve no later than 10 PM. In regards to placement of the carts, back wheels should be close to the curb and there should be sufficient distance (approximately two feet) between carts to allow space for the arms of the truck space to pick up the carts. The debris going into the cart should be bagged to eliminate it from flying out onto the street or into yards. Do not bag recyclable items going into the recycle cart. Mayor Pierce commended the drivers. She asked Council to email Ms. Vernon if there are any other changes to be considered.

j. <u>Update, Discussion And Possible Action On Volleyball Court Project And Location</u>

Harold Shaw – He said the safest location for the volleyball court is the site that was approved by City Council in October 2020. The location is by the basketball courts near the Senior Center. The construction plans will be submitted to City Manager Vernon. He urged the City to use white wash sand.

Susan Street – She asked Council to include the Planning and Zoning Commission in the process.

k. <u>Discussion And Possible Action On Resolution No. R-2021-732 A Resolution Authorizing The City Manager To Submit An Application For Funding From The Program Year (PY) 2021 Allocation Of Bexar County's Community Development Block Grant (CDBG) Program.</u>

City Manager Vernon said the next street on the Street Assessment Plan is Alan Shepard. There was discussion about which street to submit for the grant.

City Manager Vernon encouraged residents to attend Commissioners Court, sign up to speak or write a letter to Commissioner Calvert to share your concerns with him.

Mayor Pro-Tem Grant moved to accept Resolution No. R-2021-732 a Resolution authorizing the City Manager to submit an application for funding from the Program Year (PY) 2021 allocation of Bexar County's Community Development Block Grant (CDBG) Program to reconstruct Alan Shepard; Bexar County Funding Request \$500,000; City Cash Match \$221,200; Improvements Total Cost \$721,200; seconded by Council Member Salazar. The motion carried with a 7-0 vote.
