Mayor Aldrich called the meeting to order at 7:00 P.M.

# 6. <u>Consideration Of And Action On Minutes</u>

- a. <u>Special Meeting July 8, 2021</u>
- b. <u>Regular Meeting July 8, 2021</u>

Council Member Apodaca moved to accept the Minutes of July 8, 2021 Special Meeting and July 8, 2021 Regular Meeting; seconded by Council Member Street. The motion carried with a 7-0 vote.

# 7. <u>Presentation</u>

# a. <u>Recognition Of Municipal Court Clerk</u>

City Manager Vernon recognized Marcus Gonzales for achieving Level 1 Certification as a Texas Municipal Court Clerk.

### b. <u>Bexar County Economic and Community Development Resources, Jo Estrada</u>

Jo Estrada presented the resources available through Bexar County Economic and Community Development Department. They have funds for utility assistance and rental assistance for individuals who meet the requirements.

Robert Reyna, Community Development Department, provided information on grants that are available.

# c. <u>Badge Pinning And Swearing In Of New Police Officer</u>

Interim Chief Cardona introduced Justin Lopez. He received his Police Officer pin and City Secretary swore him in as a new police officer.

# 8. <u>General Discussion And Possible Action</u>

a. Discussion And Possible Action On Ackerman Road Project Plans And Sewer Repairs, M&S Engineering

Grady Kosub, M&S Engineering, presented the process for the Ackerman Road Project Plans and sanitary sewer recommendations. Mr. Kosub was also available to answer questions from City Council. Estrella Martinez – She said she is concerned about the ingress/egress to her business on her property on Ackerman Road.

Council Member Salazar moved to approve Sewer Plan #1 Performing point repairs to the existing sewer line and rehabilitate existing manholes - estimated cost - \$185,000 (recommendation (1) has been itemized on the final Cost Estimate for the project); seconded by Mayor Pro-Tem Grant. The motion carried with a 5-2 vote.

Council Member Salazar moved to approve Ackerman Road Project plans; seconded by Mayor Pro-Tem Grant. The motion carried with a 6-1 vote.

# b. <u>Discussion And Possible Action To Consider Joint Funding With Alamo Area Mutual</u> <u>Housing Association, DBA Alamo Community Group For Explorer Street And</u> <u>Telstar Drive</u>

City Manager Vernon provided the history on this item. There were not any representatives from Alamo Area Mutual Housing Association, DBA Community Group.

Mayor Pro-Tem Grant moved to postpone this item; seconded by Council Member Salazar.

c. Discussion And Possible Action On Ordinance No. O-2021-898 Authorizing The City To Enter Into An Agreement For Ambulance (EMS) Billing Services And Authorizing The Mayor Or The City Manager To Execute Such Agreement. This Is The First Reading.

Fire Chief Hilburn presented the bids that were received.

- 1. Ambulance Billing Systems (ABS)
- 2. ZOLL (Reporting Software, not an EMS billing Service)
- 3. Emergicon Billing
- 4. Fire Recovery
- 5. Specialized Billing (current provider)
- 6. Quick Med Claims (Kirby too small to work with at current time)
- 7. Texas EMS Billing (No Contact)

After discussing the different rates for the companies, Mayor Pro-Tem Grant moved to accept Ordinance No. O-2021-898 authorizing the City to enter into an agreement with Specialized Billing Systems for Ambulance (EMS) Billing Services with a 9% reporting fee and

authorizing the Mayor or the City Manager to execute such agreement; seconded by Council Member Martin. The motion carried with a 7-0 vote.

d. <u>Discussion And Possible Action On Potential Changes To Ordinance No. O-2018-</u> 847 Including A Revision To Sewer Service Charges And Providing For A Penalty.

Michael Ives, Public Works Director, presented the proposed changes to the ordinance.

The changes approved by Council are as follows:

\$100 unauthorized use of water; \$200 reconnection fee; new commercial accounts \$300 deposit; fees for meter and impact fees. The meter and impact fees are as follows:

City Manager Vernon provided a re-cap on the event. Revenue from sponsors and parking - \$19,670.00 and expenses - \$14,363.48.

f. <u>Discussion And Possible Action On Appointing Up To Four Alternate Members To</u> <u>The Building And Standards Commission</u>.

One application was submitted by Jakub Kosiba volunteering to serve on the Building and Standards Commission. Mr. Kosiba was available to answer questions.

Mayor Pro-Tem Grant moved to appoint Jakub Kosiba as an alternate member to the Building and Standards Commission; seconded by Council Member Apodaca. The motion carried with a 7-0 vote.

Council Member Apodaca moved to reappoint Julie Hinojosa and Clay McBee to the Planning and Zoning Commission with terms expiring August 2023; seconded by Council Member Grider. The motion carried with a 7-0 vote.

City Manager Vernon presented the current information on the American Rescue Plan Act funds.

City Council concurred for the first year the funds could be used for water/sewer, Gaiety Lane and fire hydrants.

City Manager Vernon included in the packet a copy of the current employee pay scale and compensation. City Council discussed the information.

Council Member Salazar moved that Council Members Grider, Apodaca and Martin attend the Texas Municipal League Conference October 6-8, 2021 in Houston; seconded by Mayor Pro-Tem Grant. The motion carried with a 6-1 vote.
