a. <u>Presentation And Discussion On City Of Kirby Drainage Master Plan, Givler Engineering</u>

David Givler, Givler Engineering, presented the Drainage Master Plan. He identified areas of interest. His recommendations included inspections, incorporate drainage into street repair, consider funding, prioritize projects, phased proposed projects. Also, work from downstream to upstream. He was available to answer questions.

b. On A Zoning Change Request For The Property Located At CB 5903, BLK LOT 8, Otherwise Known As 3902 Ackerman Road, Kirby, TX 78219, Which Is Zoned Single Family Dwelling District (R-1) To Be Rezoned As Multiple Family Dwelling District (R-2) Property.

Mr. Bundick was available to answer questions from Council.

Council Member Salazar said he was concerned that there will be an increase in property taxes.

Council discussed the request and spot zoning.

City Manager Vernon said the City Attorney's opinion was that this is considered spot zoning even if you add a multi-unit building in the middle of a Single Family District (R-1), even if it's not an apartment complex. There has been case law in both directions saying whether this is allowable.

Council Member Street moved to accept the zoning change request for the property located at CB 5903, Blk Lot 8, otherwise known as 3902 Ackerman Road, Kirby, TX 78219, which is zoned Single Family Dwelling District (R-1) to be rezoned as Multiple Family Dwelling District (R-2) property; seconded by Council Member Apodaca. The motion carried with a 4-3 vote.
