# Monique,

I understand that you will not place the items requested by two council members on the July 14 meeting agenda because you will not be there. Section 3.01, d, items 1 and 4 state that you are to enforce the ordinances and attend council meetings unless you are excused. I can only take this as you not willing to do your duty in making the agenda and following the city ordinance/charter, and I am requesting that you place an executive session on the July 14, 2022 agenda to discuss your performance. See Section 3.01 below.

The City Manager shall continue to receive his or her salary until the effective date of a final resolution of removal.

Powers and Duties:

The City Manager shall be the Chief Administrative Officer of the City, and shall be responsible to the Council for the proper administration of all the affairs of the City and to that end shall have the power to be required to:

See that all State laws and City ordinances are effectively enforced.

Prepare, update and submit a personnel policies manual in accordance with State and Federal regulations for City Council approval annually.

(3) Appoint, suspend or remove all or any one of the directors of departments, except as otherwise provided in this Charter.

Attend all meetings of the Council except when excused by Council, and shall have the right to take part in the discussions.

(5) Prepare the budget annually and submit it to the Council and be responsible for its administration after it adoption.

(6) Submit to the Council and make available to the public a complete report on the finances and administrative activities of the City as of the end of each fiscal year.

Keep the Council advised of the financial condition and future needs of the City and make such recommendations as may seem to him or her advisable.

Make other such reports as the Council may require concerning the operations of City departments, offices and agencies subject to his or her direction and supervision.
