City Manager Vernon explained the City leases 100-acre feet of ground water through RWRDG and the lease will expire December 31, 2019. If Council approves the Groundwater Lease Agreement, the new lease will expire December 31, 2024 and the cost will be \$130 per acre foot. The cost is funded through our water fund.

Council Member Pierce moved to accept \$13,000 2024; seconded by Mayor Pro-Tem Aldrich. The motion carried with a 6-0 vote.

Council Member Wilson – She said she is responsible keeping her property clean and garbage picked up and everyone else should abide by the same rules. She inquired if the property across the street from Big Boy's is required to have parking spaces. She has received complaints about overhanging limbs on roadways. She thanked Chris Garza and his group for trying to do different things for the City of Kirby.

Council Member Pierce – He thanked everyone for attending the meeting and expressed to Chris Garza to keep going and echoed Council Member Wilson's comments.

Mayor Pierce – She asked that all the forms that can be downloaded onto the website be posted under one tab. She asked that we revisit the ordinance that addresses the garbage cart placement, maintaining alleys and continue to promote MyGov. She asked that the issue with the easements on Springfield Road be resolved and completion of Binz Engleman Road reconstruction project. She asked that the barb wire on Springfield Road property be addressed. The Planning and Zoning Commission and Building and Standards Commission have not been able to conduct their meetings due to the lack of a quorum. This prohibits progress in the City. She requested a joint meeting, on a Saturday morning, between the Planning and Zoning Commission and Building and Standards Commission with City Council. She suggested addressing this after the budget has been adopted. She thanked everyone for attending the meeting and for their comments.
