**ORDINANCE NO. 2025 - 1130**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KIRBY APPOINTING CARLOS QUEZADA AS PRESIDING MUNICIPAL COURT JUDGE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Kirby, Texas is a home-rule municipality located in Bexar County, Texas and duly established under the Texas Constitution and the laws of this State; and

**WHEREAS**, there is a vacancy in the office of Presiding Municipal Court Judge and the City desires to appoint Carlos Quezada to the office for the remainder of the term, set to expire June 14, 2027; and

**WHEREAS**, City Council believes it to be in the best interest of the City to appoint Carlos Quezada to the office to ensure the orderly and effective exercise of the City's municipal court authority.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS, THAT:**

**Section 1.** The City Council hereby appoints Carlos Quezada as the Presiding Municipal Court Judge for the City of Kirby.

**Section 2.** That the recitals contained in the preamble hereto are hereby found to be true and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.

**Section 3.** This Ordinance shall be cumulative of all provisions of ordinances of the City of Kirby, Texas, except where the provisions of the Ordinance are in direct conflict with the provisions such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed. Any renumbering shall be made as necessary in the City's Code of Ordinances as necessary.

**Section 4.** It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

**Section 6.** This ordinance shall take effect immediately from and after its passage.

### **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KIRBY APPOINTING DARRELL DULLNIG AS ASSOCIATE MUNICIPAL COURT JUDGE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Kirby, Texas is a home-rule municipality located in Bexar County, Texas and duly established under the Texas Constitution and the laws of this State; and

**WHEREAS**, there is a vacancy in the office of Associate Municipal Court Judge and the City desires to appoint Darrell Dullnig to the office for the remainder of the term, set to expire June 14, 2027; and

**WHEREAS**, City Council believes it to be in the best interest of the City to appoint Darrell Dullnig to the office to ensure the orderly and effective exercise of the City's municipal court authority.

**Section 4.** It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

**Section 5.** That it is officially found, determined and declared that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this ordinance, was given, all as required by Chapter 551, as amended, Texas Government Code.
