

ORDINANCE NO. O-2025-928

AN ORDINANCE OF THE CITY OF KIRBY APPROVING AND ADOPTING AN AMENDING TO THE BUDGET FOR OPERATING THE MUNICIPAL GOVERNMENT OF THE CITY OF KIRBY, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING SEPTEMBER 30, 2025; REPEALING ALL ORDINANCES AND APPROPRIATIONS IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE; AND ESTABLISHING A SAVINGS CLAUSE AND AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Kirby previously adopted a budget for the City's 2024-2025 fiscal year; and

WHEREAS, the City Council of the City of Kirby desires to amend the operating budget of the municipal government of the City of Kirby for the fiscal year October 1, 2024 to September 30, 2025; and

WHEREAS, Chapter 102 of the Local Government Code and the Charter of the City of Kirby provides the City with the authority to make changes in its budget for municipal purposes; and

WHEREAS, the City Council finds and determines that it is necessary to amend the budget for municipal purposes; and

WHEREAS, the City Council hereby finds and determines that the budget amendment provided for herein is in the best interests of the municipal taxpayers.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRBY, that the budget for Fiscal Year 2024-2025 is amended as follows:

SECTION 1. That the City of Kirby fiscal year 2024-2025 budget shall be amended as indicated in the attached Exhibit A.

SECTION 2. The findings set out herein are found to be true and correct and are hereby adopted by the City Council and made a part of this Ordinance for all purposes.

SECTION 3. All ordinances or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters herein.

SECTION 4. If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this Ordinance would have been enacted without such invalid provision.

Section 5. It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public and that public notices of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

Section 6. This Ordinance shall be in force and effect from and after its final passage, and any publication required by law.

ORDINANCE NO. 2025 - 2002

AN ORDINANCE OF THE CITY OF KIRBY, TEXAS, ADOPTING THE 2021 EDITION OF THE INTERNATIONAL BUILDING CODE; PROVIDING FOR AMENDMENTS; PROVIDING FOR ENFORCEMENT; PROVIDING FOR A PENALTY; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Kirby (“City”) is authorized under state law to adopt building regulations to promote the public health, safety, and general welfare of the community; and

WHEREAS, the International Code Council has published the 2021 Edition of the International Building Code (“IBC 2021”), which establishes minimum regulations for building systems using prescriptive and performance-related provisions; and

WHEREAS, the City Council finds that adoption of the IBC 2021 is necessary to ensure modern, consistent, and enforceable building standards within the City; and

WHEREAS, the City Council further finds that adoption of the IBC 2021 will enhance safety, support orderly development, and provide uniformity with regional and statewide building practices;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS:

SECTION 1. ADOPTION OF THE 2021 INTERNATIONAL BUILDING CODE

The City of Kirby hereby adopts the **2021 Edition of the International Building Code**, including Appendices as deemed appropriate by the Building Official, as the official building code of the City. A copy of the IBC 2021 shall be maintained on file in the office of the City Secretary and made available for public inspection.

SECTION 2. AMENDMENTS

The City Council may, from time to time, adopt amendments to the IBC 2021 as necessary to address local conditions. Any such amendments shall be codified by ordinance and incorporated into the City’s Code of Ordinances.

SECTION 3. ENFORCEMENT

The provisions of the IBC 2021 shall be administered and enforced by the City’s Building Official or designee. The Building Official is authorized to issue permits, conduct inspections, and take any action necessary to enforce compliance with this ordinance and all applicable building regulations.

SECTION 4. PENALTY

Any person, firm, or corporation violating any provision of the IBC 2021 or this ordinance shall be subject to penalties as provided by the City's Code of Ordinances. Each day a violation continues constitutes a separate offense.

SECTION 5. SEVERABILITY

If any section, subsection, clause, or phrase of this ordinance is found to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 6. EFFECTIVE DATE

This ordinance shall take effect immediately upon its passage and approval.
