**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS
AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS TO OBTAIN
AND ENTER INTO AN AGREEMENT WITH _____ FOR
VIDEO SURVEILLANCE EQUIPMENT**

WHEREAS, the City of Kirby needs to ensure the safety of its employees and citizens at its City Hall and other city owned properties; and

WHEREAS, the video surveillance equipment will enable the City of Kirby to better monitor its property; and

WHEREAS, it is the best financial interests of the City of Kirby to enter said agreement in the amount of\$ _____ per year.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS:

Section 1. The City Council of the City of Kirby, Texas hereby authorizes the City Manager to enter into an agreement with _____ for video surveillance equipment.

Section 2. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the City Council.

Section 3. All resolutions or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

Section 4. This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

Section 5. If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this Resolution would have been enacted without such invalid provision.

Section 6. It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, Texas Government Code, as amended.

Section 7. This Resolution shall be in force and effect from and after its final passage, and it is so resolved.

ORDINANCE NO. 2025 - 2000

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS,
ADOPTING THE CITY OF KIRBY SOCIAL MEDIA POLICY TERMS OF USE,
ESTABLISHING THAT THE CITY OF KIRBY WILL DISABLE AND PROHIBIT
PUBLIC COMMENTS ON ALL CITY-MANAGED SOCIAL MEDIA PLATFORMS;
PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City of Kirby maintains official social media accounts for the purpose of disseminating information to the public regarding City services, programs, events, and emergency notifications; and

WHEREAS, the City Council finds that enabling public comments on City-managed social media pages may create administrative burdens, potential misinformation, and challenges related to monitoring, moderation, and compliance with applicable laws; and

WHEREAS, the City Council seeks to ensure that information shared on official City platforms remains accurate, timely, and reflective of the City's official positions; and

WHEREAS, the City Council desires to establish a clear policy that public comments will not be permitted on any City of Kirby social media accounts in order to maintain these platforms as informational tools rather than public forums;

WHEREAS, the City Council finds that the City of Kirby's presence on social media sites and platforms is intended for informational purposes only; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS, THAT:

Section 1. The City of Kirby shall disable and prohibit public commenting features on all City-operated and City-authorized social media platforms.

Section 2. All City social media pages shall be used solely for the purpose of providing official information and announcements on behalf of the City.

Section 3. City staff are directed to ensure consistent implementation of this policy across all existing and future social media accounts maintained by the City.

Section 4. If any provision of this ordinance is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Section 5. If any section, subsection, clause, or phrase of this ordinance is found to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 6. This ordinance shall take effect immediately upon its passage and approval.

Council members may still have their own political or personal social media pages where they may discuss topics which are important to their constituents and the City of Kirby.

RESOLUTION NO. 2025-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRBY, TEXAS,

APPROVING THE BEXAR COUNTY APPRAISAL DISTRICT OFFICIAL

CORRECTED NOTICE FOR THE APPOINTMENTS TO THE 2026 BEXAR CENTRAL

APPRAISAL DISTRICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN

EFFECTIVE DATE.

WHEREAS, the City of Kirby as a taxing entity in Bexar County, Texas has been notified by the Bexar Central Appraisal District that it has issued an official corrected notice of 2025 voting entitlements for the appointment of members to the 2026 Bexar Central Appraisal District Board of Directors; and

WHEREAS, the official corrected notice replaces and supersedes the previous notice issued on October 20, 2025, was incorrect as it was determined that the total number of votes distributed was incorrectly calculated as 5,000 instead of 2,000, due to a misapplication of the multiplier in Tax Code§ 6.03(d); and

WHEREAS, under Texas Property Tax Code § 6.03(d), the number of votes distributed among participating taxing units must be determined by the voting entitlement of a taxing unit which is by dividing the total dollar amount of property taxes imposed in the district by the taxing unit for the preceding tax year by the sum of the total dollar amount of property taxes imposed in the district for that year by each taxing unit that is entitled to vote, multiplying the quotient by 1,000, and then by the number of directorships to be filled; and

WHEREAS, the Bexar Central Appraisal District has determined for the 2026 term, two (2) directorships are to be filled (corresponding to the expiration of the one-year staggered terms drawn in 2024); and

WHEREAS, the total number of votes available for distribution is 2,000 ($1,000 \times 2$ directorships); and

WHEREAS, the previous notice inadvertently retained the 2024 transition-year total of 5,000 votes, which applied when five positions were being filled; and

WHEREAS, the vote totals must now be adjusted; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF

KIRBY, TEXAS, THAT:

1. The City of Kirby hereby approves the Bexar Central Appraisal District official corrected notice of 2025 voting entitlements for the appointment of members to the 2026 Bexar Central Appraisal District Board of Directors;
2. The City of Kirby further finds that each taxing unit's percentage entitlement remains identical to

the previous notice;

3. The City of Kirby finds that only the total number of available votes has been corrected from 5,000 to 2,000, and any ballots previously cast using the 5,000-vote allocation are void and must be resubmitted using the corrected voting entitlement enclosed with this notice.
4. The City of Kirby finds that votes must be resubmitted by December 15, 2025, consistent with the statutory deadline in Tax Code § 6.03(k).
5. If any provision of this Resolution is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
6. This Resolution shall take effect immediately upon its adoption.
